#### **Introductory Remarks**

Co-Chairs Ward and Carney opened the meeting by thanking everyone for their attendance.

#### **Meeting Minutes**

The meeting minutes for the Corporation's September 21, 2020 Board meeting were presented by Director Ward for review and approval. Upon a motion duly made and seconded, the meeting minutes of the September 21, 2020, Board meeting were approved.

## Treasurer's Report

Director Desmond provided an overview regarding the status of the Corporation's finances and expenditures. Upon a motion duly made and seconded, the financials and expenditures were approved.

## Performance Oversight

Director Rider, committee chair, gave a brief overview of the committee's work, and introduced Ms. Harrington, who presented an in-depth case study of a recent DPP project. Comments were made by Directors Rider and Carney and Mr. Foreman.

#### Planning & Development

Director Baker, acting for committee chair Director Damon, gave a brief overview of the committee's work and introduced Mr. Foreman, who then provided a progress overview for the Advancing Prosperity Campaign.

Director Baker then introduced the committee's recommended reserves policy concept, and Mr. Foreman presented specific factors and projections. It was agreed that the committee would draft a reserves policy for approval at a future Board meeting.

Director Callahan, committee chair, gave a brief review of the committee's work and introduced Ms. Schiavoni, who presented work on Spotlight on Wilmington and digital ad campaigns. Director Ward also noted that Director Callahan would be resigning as chair of the External Relations Committee to chair the new Science & Technology Advisors group.

## President's Report

Mr. Foreman provided updates on the Corporation's operations and most recent workstreams, including the Tech Talent Pipeline effort, which Mr. Madden then reviewed in detail. Comments were made by Mr. Foreman, Directors Baker, Carney, Rider, and Lambrow, as well as Mr. Malfitano and Ms. Gruswitz.

Mr. Foreman then reviewed the Location Matters Study from Director Carney.

#### Co-Chair's Report

Director Ward provided an update on the Ready in Six initiative, with comments from Director Carney.

Director Carney spoke briefly about the state budget, with comments from Director Ward.

Director Carney then moved on to thank and recognize the contributions of departing Board members, Directors Kee and Delcollo, with comments from Director Ward and Mr. Foreman.

Directors Ward and Carney also praised and thanked the DPP staff for their work during the year.
