Location Matters: Report highlights Delaware's favorable business tax climate

Delaware ranks among the top three states nationwide for business tax favorability across a wide range of business models, according to a KPMG report with research support by the Tax Foundation.

The comprehensive report, Location Matters, assesses the business tax burden in two categories of cities - major and mid-sized throughout all 50 states, accounting for the wide range of tax impacts faced by businesses, such as property tax, income tax, sales tax and others. For Delaware, Wilmington ranked in the report as a Tier 1 major city (population greater than 50,000); Dover in the Tier 2 mid-sized category.

"Corporate tax structure is an important variable for businesses considering a new location," said Rod Ward, who co-chairs the DPP Board of Directors with Governor John Carney. Ward says, "This report validates an important variable in Delaware's value proposition for businesses contemplating their next move."

States are ranked within eight business models: corporate offices; research & development; tech centers; data centers; distribution centers; capital-intensive manufacturing; labor-intensive manufacturing; and shared services.

Overall, Delaware outpaced its neighboring states in the Mid-Atlantic region for most sector types in both the new and mature business categories.

"Creating long-term, well-paying jobs is a critical part of establishing a growing economy that contributes to the well-being of all Delawareans," said Janice Nevin, M.D., MPH, president and CEO of ChristianaCare and chair of the Delaware Business Roundtable. "This study confirms that our state is very competitive when it comes to corporate taxes, which helps to provide a good foundation for

economic growth."



Startup302 competition tackles funding inequities

Ten tech-enabled startups with at least one team member from an underrepresented demographic shared \$275,000 in funding from Delaware's first Startup302 competition organized by DPP and local partners in April 2021.

Designed to tackle funding inequities and strengthen Delaware's regional startup community, the competition leads to grant prizes, mentoring and valuable networking connections, including introductions to potential investors.

The inaugural competition attracted 82 local, regional, national and international competitors. Twenty-two finalists in nine categories representing multiple industries competed in the virtual event's final pitching round conducted on the Delaware-based startup platform Markee.

Startup302 organizers included the Delaware Sustainable Chemistry Alliance, First Founders Accelerator, the University of Delaware Horn Entrepreneurship Program, Delaware State University, Pedro Moore, Delaware Small Business Development Center and Delaware Innovation Space. Funding for the grant prizes was provided by DPP, the Delaware Division of Small Business, the University of Delaware, Delaware State University, JPMorgan Chase, Discover Bank, New Castle County, FMC, Highmark Blue Cross Blue Shield Delaware, Labware and Delaware Innovation Space. Delaware's Lab Grant Program gets \$10M boost

With oversight from Delaware's Council on Development Finance, Delaware's General Assembly in July approved the allocation of an additional \$10 million to its lab grant program for 2022. The Lab Space Grant will help with inventory of ready-to-go lab space and programming for small and early stage science and tech companies poised to commercialize their products and encourage long-term growth in Delaware.

Lab grants cover up to 33% of fit-out costs for lab space and require landlords to make good-faith efforts to fill the spaces with lab tenants. DPP helps vet life science and biopharma private sector companies already partnered with developers on specific projects to ensure they are at the right phase to qualify for lab space grants. DPP also continues to work on developing solutions and programming to address two key items: creating a more formal coordinating team to focus on longer-term innovation strategy and policy for the state, and addressing a capital gap for the startup ecosystem through designating federal funding to a venture capital fund.

DPP leaders help select EDGE Grant winners

DPP President and CEO Kurt Foreman and Director of Innovation Noah Olson helped judge the December round of the Delaware Division of Small Business' Encouraging Development, Growth and Expansion (EDGE) Grants. EDGE Grants make it easy for businesses to start – and stay – in Delaware, with \$2.75 million provided to 50 promising Delaware small businesses from a wide range of sectors since the division launched the funding program in 2019.

DPP helps Delaware develop SSBCI

DPP staff and a consultant are supporting Delaware in developing programming proposals to deploy State Small Business Credit Initiative (SSBCI) funding — a sub-program of the broader American Rescue Plan — to create one or more early stage venture funds to benefit Delaware businesses. Final determinations are pending release of formal guidelines from the SSBCI program by the Department of Treasury.





DPP collaborates with Delaware BIO on Life Sciences report




